- A. APMA and future: Dr Davis. Health care system going into a value base system and PQRS.
  - 1. How do we protect ourselves? APMA unveiled this and will begin a "registry" as a member benefit. This will collect data from members and show how many visits on average per problem. We can show our value and not allow insurance companies to determine our value for us.
