- **A.** MACRA and MIPS alternative payment methods in the pipeline from CMS, Dr. Lepoer may have some information on this for us at the next meeting. Additionally, the APMA can be a resource on this.
- **B.** Dr. Cavicchio's report from the American Society of Podiatric Executives:
  - a. New APMA executive director attended the meeting and spoke about APMA's involvement in representing us in government, updates can be viewed on the APMA's website.
  - b. APMA public relations campaign will be promoting the society of vascular surgeons, specifically venous disease and how our profession can be involved.
  - c. The full report was given to the President, Secretary and is available to anyone who wants it.
- **C.** The state of RI requires office assistants taking X-rays to take a certification course, it is available at CCRI. There is NOT an online alternative to the in person course currently. Dr. Cavvichio saw a presentation at the ASPE meeting of a group that offers an online course. Dr. Cavicchio is pursuing that through the DOH and CCRI, both of whom would have to approve it.
- **D.** American Public Health Association can be a way to network with other health professions; can be a valuable resource to us, available online.
- E. Group purchasing organization being promoted nationally, **Talar Capital Partners**. Go to <a href="https://www.talarcp.com">www.talarcp.com</a> to register. No cost to join, and you can purchase DME and office products at deeply reduced prices. Vendors included: DeRoyal, Surefit, Medline, and more includes cam boots, orthotics, wound care products, shoes, etc. Dr. Colannino has joined and can speak to anyone who is interested.
- F. APMA will be stepping up recruitment and member retention Dr. Reuter
  - a. Declaring a hardship may be available for waived or reduced membership dues
  - b. APMA is forming a member registry, which will be a free service to help us with meaningful use, and PQRS, there will be more information coming.
- **G.** Prescription Drug monitoring program membership is required in RI if you prescribe controlled substance, if you are not a member you should be! Go to <a href="https://rhodeisland.pmpaware.net/login/">https://rhodeisland.pmpaware.net/login/</a> to register.
- **H.** Using Modifier 25 on an E&M service will result in a 50% reduction in payment on the E&M when performed the same day as a procedure for Blue Cross members. This will begin October 15<sup>th</sup>. United may follow suit. The APMA is working on this.
